- **Designated Assets:** Name CRH as the beneficiary of any bank account CD, stock or mutual fund. Ask your bank or broker for information about adding a POD (Pay on Death) or TOD Transfer on Death) designation.
- **Beneficiary Designation:** Name CRH as a beneficiary or partial beneficiary of your Retirement Plan, IRA, Life Insurance or Annuity. A new beneficiary form
- **Other Gift Options:** You may want to design a gift that provides you with income today and the principal goes to CRH at death. We can provide you with illustrations of how this would work.
